BSBWHS407 – ASSIST WITH CLAIMS MANAGEMENT, REHABILITATION & RETURN TO WORK PROGRAMS (RRTWC)

DURATION 1 day programme

COURSE OUTLINE

This unit of competency will provide RRTWCs with training in developing and monitoring return to work programs within the context of the workers compensation industry in Qld:

- Initiating early communication with an injured worker to clarify the nature and severity of the workers injury to compile initial notification information
- Providing overall coordination of the workers return to work
- Developing suitable duties programme component of a rehabilitation and return to work plan in consultation with the worker and the employer
- Liaising with any person engaged by the employer to help with the workers rehabilitation including the insurer

On the 17th November 2013 Workers' Compensation and Rehabilitation and Other Legislation Amendment Act 2013 was passed in Queensland parliament. As a result of these changes QLD30782 Course in functioning as a rehabilitation and return to work coordinator is no longer regulator mandated.

It is now the responsibility of the employer to ascertain that a RRTWC is "appropriately qualified" to carry out their role in the context of the environment they are working in. The course BSBWHS407 Assist with claims management, rehabilitation and return to work programs meets key learning requirements to assist an employer's PCBU obligations.

Face to face classroom delivery will be used to facilitate the underpinning knowledge requirements.

ASSESSMENT

Participants will be assessed as they complete the unit via group based activities, workplace project activities and a theory assessment.

PREREQUISITES

There are no prerequisite requirements for individual units of competency however participants will be expected to have a range of cognitive, technical and communication skills to select and apply a specialised range of methods, tools, materials and information to:

- Complete routine activities
- Provide and transmit solutions to predictable and sometimes unpredictable problems

- Completion of Certificate IV in Government (Injury Rehabilitation Management)- PSP04
- Completion of Certificate IV in Financial Services (Workers' Compensation) – FNS41007
- Completion of any of the units of competency from the above Certificate IV courses included in this course will be credited toward this course.
