DURATION 2 days

COURSE OUTLINE

This course is a nationally accredited 2 day course run by Down To Earth Results.

The Standard 11 Skill Set from the RII Resources and Infrastructure Industry Training Package meets the QLD regulatory requirements for those aiming to work in surface mining operations.

Participants who undertake the Standard 11 program will be gaining the requisite knowledge and skills identified by industry as being of paramount importance when working on site.

The Standard 11 course ensures that the generic safety information and obligations, applicable on all types of mine sites are provided to workers prior to working on a mine site.

Skill Set Requirements

- RIICOM201D Communicate in the workplace
- RIIERR205D Apply initial first aid
- RIIERR302D Respond to local emergencies and incidents
- RIIGOV201D Comply with site work processes and procedures
- RIIWHS201D Work safely and follow WHS policies and procedures
- RIIRIS201D Conduct local risk control

ASSESSMENT

If the RTO is satisfied with participant's existing/current workplace experience, a Statement of attainment may be provided.

If any part of the required Performance Evidence cannot be gathered the Participant will be issued with a Workplace Experience Logbook. This will need to be completed on site and signed off by site Supervisors.

On completion, the Participant returns the Logbook for verification, for a Statement of Attainment to be issued.

This Skill Set is for those individuals wishing to work in surface mining operations within the coal sector.
