COURSE OUTLINE

This course is a nationally accredited three day course for supervisors in mining and construction industries and for Health Safety Representatives in the Qld mining sector.

It provides students with the opportunity to develop the knowledge and skills required to manage work groups in relation to risk management, incident investigations and quality communications.

The course is a requirement under the Qld Coal Mining Act and Regulations and the Qld Mining and Quarrying Act and Regulations for people who manage others and elected Health Safety Representatives.

These three units form part of RII30115 Certificate III in Surface Extraction Operations

RIIRIS301D Apply risk management processes

This unit covers application of risk management processes in resources and infrastructure industries. It includes identifying hazards, identifying and assessing unacceptable risk, identifying and recommending treatments, contributing to the implementation of treatments, reviewing safety system documentation and relevant legislation.

RIIOHS301D Conduct safety & health investigations

This unit covers conducting safety and health investigations in resources and infrastructure industries. It includes determining the investigations objectives, gathering information, evaluating information, identifying courses of action and preparing and presenting investigation reports.

RIICOM301D Communicate information

This unit covers the communication of information in resources and infrastructure industries. It includes communicating information orally and in writing, achieving meeting outcomes, making presentations and participating in negotiations.

Face to face classroom delivery will be used to facilitate the underpinning knowledge requirements.

ASSESSMENT

Theory and practical assessments will be conducted throughout the course.

On successful completion participants receive a Statement of Attainment.
