COURSE OUTLINE

This course provides new workers in the building and construction industry with the introductory knowledge & understanding needed to enter and work on Queensland construction and building sites unescorted. Key knowledge and skills gained from this training include;

- Identifying hazards on a construction site
- Assessing risks and implementing controls to eliminate or reduce risks associated with construction work
- Understanding basic concepts of safe work method statements, Job safety analysis and the use of safe work practices in the construction industry
- Knowledge & understanding of the principles in a risk management system and how to assess and use the hierarchy of controls
- Knowledge of how to follow emergency procedures
- The correct use and limitations of personal protective equipment

Face to face classroom delivery will be used to facilitate the underpinning knowledge requirements for this construction industry induction training.

ASSESSMENT

Assessments will be conducted during the course with a written/oral assessment to be completed at the end of the training session.

Participants who demonstrate competency by successfully completing the training & assessment will receive a Statement of Attainment and a WHSQ White Card.

WHO SHOULD ATTEND?

Participants who demonstrate competency by successfully completing the training & assessment will receive a Statement of Attainment and a WHSQ White Card.

PREREQUISITES

There are no prerequisites for this course however we recommend that new employees to the industry cluster this unit on the same day with the Hazardous Manual Task training to further their knowledge of hazards & risks in the construction industry.
